- 7.) The seller is responsible for clean-up of your space. You will be responsible for removing all trash, tables, racks, etc. from property of the sale or you will be fined for littering by the police department.
- 8.) All items must be cleaned up and removed from property no later than 12 noon that day.
- 9.) The sale will be held in the rear parking lot of The Citizens Bank in Olanta. The Citizens Bank is not responsible for any injuries, lost or stolen items.
