#### A. SRF GRANT 210006-04 LEAD/COPPER LINE INVENTORY

Mayor Welch informed the council portions of the project are completed. Requesting last draw. Still have punch list to complete.

#### B. SCIIP GRANT A-23-C154 WATER EXPANSION UPDATE

Mayor Welch informed the council that there has been about 29,000 ft of water lines. Total feet of pipe to be installed is 62,000. No taps have been installed. Door hangers have been given out to all customers of this project. Project is about halfway done.

#### C. Old Town Hall

Mayor Welch informed the council that the roof was replaced. Raised the price to cover the roof repair.

#### D. Old Library

Mayor Welch informed the council that the roof repair was completed. Already been reimbursed.

# A. Water Expansion- Butler Scurry Rd/Bethel Rd/Hwy 301/ Sewer Rehab Part 2 Mayor Welch informed the council that he has applied for money to finish Butler Scurry Rd. Also applied for a grant to finish up Bethel Rd. Asked for additional funding for the SFR to rehab the sewer.

#### B. Joint Water And Sewer Authority March 12, 2025, Meeting Update

Mayor Welch informed the council that he has done some research. The water authority are able to get to places that takes the towns longer to get to. Mayor would like to look more into this.

#### C. Business License

Mayor Welch informed the council that the funding we get from business license is roughly \$70,000 a year. If it was given to the customers, it would be \$25 a month per customer.

#### D. Grocery Store

Mayor Welch informed the council he met with the realtor, Mr. Warren Jeffers who owns the Piggly Wiggly in Lamar. The only 2 items that they were able to get the age on was, the pos which is about a year old and air conditioner on top of the building was two years old. Not sure on the freezers nor coolers but Mr. Jeffers looked at them. His suggestion was to get a refrigeration company to go through them to see if they have potential. Did see the tax returns for 2019 – 2024 IGA brought in between 2.3 million and 2.6 million.

## E. Assistant Clerk Position Posting

Mayor informed the council that the town has a position open for Assistant Clerk. Part time and hours are 8 to 5.
