Old Business

A. SCIIP GRANT A-23-C154 WATER EXPANSION - UPDATE

Mayor Welch informed the council that the project has all the bores are almost done. Still have one major bore under 378. All meter boxes have been installed. Only thing left is to connect to Coward and Barrineau.

B. SRF GRANT 210006-06 LEAD/COPPER LINE INVENTORY

Mayor Welch informed council that the funding is ready. Eastern Engineering is in the process of doing the engineering on the last 3 lines.

C. WATER AUTHORITY - UPDATE

Mayor Welch informed council that council member Jordan and himself attended a meeting. Still looking into more information about the pros and cons in joining the water authority.

A. EXECUTIVE SESSION

Mayor Welch informed the council that state income tax was brought down from 7% to 6% working to get rid of the state income tax. The benefits to that will be the employee gets to keep the 6% on their paychecks. Drawback is that it removed any earmarks for extra funding for the small towns.

Street side parking is okay so no parking lot will be needed. Mayor Welch will get with some structural engineers to see if the building is salvageable.
